Please note that such request for receiving the Corporate Communications in printed form ("Printed Form Request") shall be valid from the receipt date of the relevant Reply Form/email and up to 31 December 2024 (the "Initial Request"). If you want to extend the Period of Request after the expiry of the Initial Request, you shall complete and return the Request Form (available from the website of the Company at www.fengxiang.com) or send an email to the H Share Registrar in accordance with the instructions above no later than 31 December each year to extend the Period of Request for the next calendar year. Each Request Form shall be valid until 31 December of the relevant calendar year. Shareholder is still entitled to submit the Request Form at any time before 31 December and the validity period of such Printed Form Request will be up to 31 December of the relevant year.
